

3. SCOPE OF WORK / SPECIFICATIONS

This RFB covers the requirements to provide a walk-in cooler and walk-in freezer as outlined below. SCS reserves the right to award each item (individually or by group) to separate vendors or all items to one vendor.

ALTERNATES: Unless otherwise provided for in this RFB, the name of a certain brand, make or manufacturer does not restrict bidders to the specific brand, make or manufacturer named, but conveys the general style, type, character, and quality of the item desired. ALL requests for alternate products must be approved, in advance, by the SCS Supervisor of School Nutrition. ANY bidder that fails to secure preapproval for a substitute product will not be considered. SCS, in its sole discretion, shall determine what items are equal to the specified equipment. It is the bidder's responsibility to indicate the product clearly and specifically being offered. Failure to disclose the equipment included in the RFB submission shall result in declaring a bid non-responsive.

INSTALLATION: The cost for each piece of equipment must include all shipping cost (freight, inside delivery & uncrating), installation (disconnection/final electrical & water connections) and training. The bidder must demonstrate a fully functional piece of equipment. The bidder shall be responsible for the removal and disposal of existing equipment.

Manufacturer: THERMO-KOOL, or pre-approved alternate

Description:

- 1. Exterior Dimensions shall be 15'7" x 9' 9" x 8'9" H
- 2. Panel specifications: All panels shall consist of metal pans formed to precise dimensions. Metal finish to be as specified. Insulation shall be "foamed-in-place" urethane to bond permanently to complete inner surfaces of both interior and exterior metal pans to form strong rigid unit. Panels shall not have internal wood or metal support, framing, straps, or other non-insulating members. Each panel shall be 100% urethane foam insulation exclusive of metal pans. Perimeter structure shall be formed of Durathane, high density urethane insulation forming tongues and grooves to assure vapor and airtight joints and to prevent pre-installation damage and deterioration of exposed urethane surfaces. Insulation shall be 4" thick rigid, zero ozone depleting HFC 134a blown Class I urethane foam classified according to UL 723 (ASTM-E-84) as tested by Underwriters Laboratories, Inc. The core material has a flame spread of 25 or less and a smoke density of 250. The urethane foam is foamed-in-place to bond to inner surfaces of metal pans having an average thermal conductivity (K factor) of 0.13 BTU/hr./sq. ft. per degrees /Fahrenheit/inch. As tested in accordance with ASTM C 518-2004, the R factor for coolers at temperatures of 55 F° is greater than 29.0 for 4" thick; for freezers at temperatures of 20 F° the R factor is greater

The prefabricated urethane foamed panels shall be supplied with a Class I fire hazard classification according to UL 723 (ASTM-E-84) as tested by Underwriters Laboratories, Inc. Panels shall have a flame spread rating of 25 or less and bear a certifying Underwriters Laboratories, Inc. label. This rating is not intended to reflect hazards presented by this or any other material under actual fire conditions. NSF listed double-bead vinyl gasket shall be applied to the tongue side of all panels, on both interior and exterior. Gaskets shall be impervious to stains, grease, oils, mildew, sunlight, etc.

A positive action hydraulic door closer (required to meet 2009 Energy Code) shall be included to ensure gentle closing action of door to opening and to ensure positive closing of door. The latch shall be of high-pressure zinc die cast with highly polished chrome finish. Two (2) hinges per door shall be nine-inch modified strap, cam-lift, self-closing design with door lift off capability of high-pressure zinc die cast with highly polished chrome finish. (a spring-loaded hinge required to meet 2009 Energy Code). - 19. Quality Inspection Requirements: Walk-ins shall be set up at the manufacturer's facility prior to shipment and a quality control inspection performed on the product. A digital photograph of the walk-ins set up at the manufacturer's facility shall be provided for the food equipment dealer's permanent records.

- 1. Shelving units shall be epoxy coated wire shelving.
- 2. Heavy duty wire construction.
- 3. Easy to assemble.

The shelving units are to be assembled and placed in the cooler walk-in by the successful bidder. Awarded bidder to verify shelving sizes for walk-in.

INSTALLATION REQUIREMENTS FOR SUCCESSFUL BIDDER:

- 1. Deliver, uncrate, fully erect all panels starting with level floor panels and set in place condensing unit. Remove crating from the premises. Make all refrigeration connections from condensing unit to evaporator coils and make final electrical connections to electrical disconnects supplied by Sumner County Schools. Insulate drain line and install heater to drain line from evaporator coil. Drain line must have P-trap.
- 2. Condensing units to be placed in existing location.

- 3. Easy to assemble.

The shelving units are to be assembled and placed in the freezer unit by the successful bidder. Awarded bidder to verify shelving sizes for walk-in. Dunnage rack to be located under evaporator coils.

INSTALLATION REQUIREMENTS FOR SUCCESSFUL BIDDER:

 Deliver, uncrate, fully erect all panels starting with level floor panels and set in place condensing unit. Make all refrigeration connections from condensing unit to evaporator coils and make final electrical connections to electrical disconnects supplied by Sumner

- County Schools. Insulate drain line and install heater to drain line from evaporator coil. Drain line must have P-trap.

- 3. Install membrane roof cap sloped away from building and install flashing to building to prevent rainwater from penetrating walk-in roof panels.

- 1. Shelving units shall be adjustable, aluminum construction.
- 2. Heavy duty, full welded shelf construction.

Remove and dispose of existing shelving units in dry storage area. The shelving units are to be assembled and placed in the dry storage area by the successful bidder. Awarded bidder to verify shelving sizes for walk-in.

4. STANDARD CONTRACTOR OBLIGATIONS

- A. Shall provide and obtain all necessary materials, equipment and labor to perform all items listed in the Scope of Work.
- B. Shall provide and obtain all necessary permits and schedule all necessary inspections with Local, County, etc. agencies as required by law.
- C. Shall dispose of all generated waste materials in compliance with all Local, State and Federal guidelines, regulations and requirements.
- D. Shall have property trained and experienced staff to facilitate the services specified in the Scope of Work. If applicable, the Contractor shall provide documentation that staff has received the manufacturers' certification to complete the services specified in the Statement of Work.

5. FUNDING OUT CLAUSE

Any/all contracts exceeding one (1) year shall include a standard "funding out" clause. SCS retains the right to terminate a contract at the expiration of each budget period during the term of the contract and is conditioned on the best efforts of SCS to obtain appropriate funds for payment of the contract. SCS's budget year begins on July 1 and end on June 30 of the following year.

6. TAX EXEMPT STATUS

SCS is a tax-exempt governmental entity. A copy of SCS's form will be made available upon request.

7. INVOICING & PAYMENT TERMS

SCS requires Net30 terms from the date of the invoice. SCS shall accept requests for progress payments provided supporting documentation is included to support the request.

Final payment will not be processed until 100% of the work is complete and SCS has signed off on the project.

SCS requests a contact person in accounting. The contact should be responsive to our invoicing questions and be accurate in producing detailed reporting and other information relevant to our account.

PREPARATION AND SUBMISSION OF BID

- 1. Failure to examine any drawings, specifications, or instructions will be at the Bidder/Proposer's risk. Any deviation from the stated terms, conditions and specifications must be coordinated with and approved in writing by the SCS Purchasing Supervisor.
- 2. RFB/RFP/ITB SUBMITTAL / SIGNATURE: Submittal shall give the full name and business address of the Bidder/Proposer. If the Bidder/Proposer is a corporation, the name shall be stated as it is in the corporate charter. Submittals must be signed in ink by the Bidder/Proposer authorized agent. Each sample must be labeled with the interested parties' name, manufacturer's brand name and number, RFB/RFP/ITB number and item reference.
- 9. Time of Performance: The number of calendar days in which delivery is to be made after receipt of order shall be stated in the RFB/RFP/ITB and may be a factor in making an award, price notwithstanding. If no delivery time is stated in the bid, the Bidder/Proposer agrees that delivery is to be made within two weeks (10 business days) of order.
- 10. Transportation and delivery charges should be included in the price and be fully prepaid by the vendor to the destination specified in the RFB/RFP/ITB. Submission prices shall include delivery of all items F.O.B. destination.
- 11. New materials and supplies must be delivered unless otherwise specifically stated in the RFB/RFP/ITB.
- 12. Alternate/multiple bids will not be considered unless specifically called for in the RFB/RFP/ITB.
- 13. Only proposals submitted on RFB/RFP/ITB forms furnished by SCS will be considered.
- 14. By signing this RFB/RFP/ITB where indicated, Bidder/Proposer agrees to strictly abide by all applicable local, state and federal statutes and regulations. The Bidder/Proposer further certifies that this submission is made without collusion or fraud.
- 15. Error in Submission. In case of error in the extension of prices in the submission, the unit price will govern. Late submissions will NOT be opened or considered. Bidder/Proposer are cautioned to verify their submission, as amendments received after the RFB/RFP/ITB deadline will not be considered. No submission shall be altered, amended or withdrawn after opening. After submission opening, a Bidder/Proposer may withdraw a submission only when there is obvious clerical error such as a misplaced decimal point, or when enforcement of the submission would impose unconscionable hardship due to an error in the submission resulting in a quotation substantially below the other submissions received. Submission withdrawals will be considered only upon written request of the Bidder/Proposer.

OPEN RECORDS

In order to comply with the provisions of the Tennessee Open Records Act, all submissions will be publicly opened and are subject to public inspection after the award upon written request. A Bidder/Proposer may be present at RFB/RFP/ITB opening. Summary information will be posted the SCS website, www.sumnerschools.org under the Invitation to Bid link.

ACCEPTANCE AND AWARD

- 1. SCS reserves the right to reject any and all submissions and to waive any informality in submission and, unless otherwise specified by the Bidder/Proposer to accept any item in the submission. Action to reject all submissions shall be taken for unreasonably high prices, errors in the submission documents, cessation of need, unavailability of funds, or any other reason approved by SCS.
- 2. Contracts and purchases will be made with the lowest, responsive, responsible, qualified Bidder/Proposer. The quality of the articles to be supplied, their conformity with the specifications, their suitability to the requirements of the Institution, cash discount offered, and the delivery terms will be taken into consideration.
- 3. Any deviation from these stated terms, specifications and conditions must be coordinated with and approved in writing by the Purchasing Supervisor.
- 4. Prices quoted in the submission (if any) are to be considered firm and binding until the said equipment, supplies or services are in the possession of SCS.
- 5. If, during the performance of this contract, the cost of materials increases, through no fault of the contractor, the price of materials shall be equitably adjusted by an amount reasonably necessary to cover any such increase in the cost of materials. The Bidder/Proposer shall provide evidence of the cost increase prior to its' implementation. Annual or Multi-Year Contracts ONLY. Any increase in cost must be approved by SCS.
- 6. SCS reserves the right to order more or less than the quantity listed in the proposal.
- 7. If a Bidder/Proposer fails to state a time within which a Bidder/Proposer must be accepted, it is understood and agreed that SCS shall have ninety (90) days to accept.
- 8. No purchase or contract is authorized or valid until the issuance of a SCS purchase order in accordance with SCS policy. No SCS employee is authorized to purchase equipment, supplies or services prior to the issuance of such a purchase order.
- 9. The contract may not be assigned without written SCS consent.
- 10. If the appropriate space is marked on the RFB/RFP/ITB, other Institutions (such as State, Local and/or Public Agencies) may purchase off the contract during the same period as SCS.
- 11. The awarded Bidder/Proposer will be required to post a performance and payment bond in the amount of 25% of the contract price if it exceeds \$100,000 as stated by T.C.A. §12-4-201.
- 12. If the project cost is in excess of \$25,000 a performance bond must be secured by the requesting part in an amount equal to the market improvement value.
- 13. By submission of this bid and signature thereof, the Bidder/Proposer acknowledges compliance with the provisions of Public Chapter No. 587 / Senate Bill No. 2048 (Employee Background Check). The Bidder further agrees to submit a formal certification thereof prior to commencing work.

PAYMENT

Payment terms must be specified in the submission, including any discounts for early payment. Partial payments will not be approved unless justification for such payment can be shown. Terms will be NET 30 days. Payment will not be made until the conditions and specifications of the RFB/RFP/ITB are inspected and approved as conforming by persons appointed by SCS.

DEFAULT OF SELECTED VENDOR

In case of Bidder/Proposer default, SCS may procure the articles or services from other sources and hold the defaulting Bidder/Proposer responsible for any resulting cost. If the awarded Bidder/Proposer violates any terms of their response, the contract, SCS policy or any law, they may be disqualified from submitting for a period of two years for minor violations or longer for major violations. Submissions from disqualified Bidder/Proposer will not be accepted during the period of disqualification.

INSPECTION OF PURCHASES

Articles received which are not equivalent will not be accepted and will be picked up by the Bidder/Proposer or returned to Bidder/Proposer, shipping charges collect. SCS shall have a reasonable period in which to inspect and accept or reject materials without liability. If necessity requires SCS to use nonconforming materials, an appropriate reduction in payment may be made.

TAXES

SCS is tax exempt; do not include taxes in quotation. Bidder/Proposers making improvements or additions to or performing repair work on real property for SCS are liable for any applicable sales or use tax on tangible personal property used in connection with the contract or furnished to vendors by the state for use under the contract.

NONDISCRIMINATION

SCS is an equal opportunity employer. SCS and bidder agree to comply with Titles VI and VII of the Civil Rights Act of 1964, Title IX of the Education Amendments of 1972, Section 504 of the Rehabilitation Act of 1973, Executive Order 11,246, the Americans with Disabilities Act of 1990, if applicable, and the related regulations to each. Each party assures that it will not discriminate against any individual including, but not limited to employees or applicants for employment and/or students, because of race, religion, creed, color, sex, age, disability, veteran status or national origin. In the event that any claims should arise with regards to violations of any such local, state or federal law, statues, rule or regulations, the vendor will indemnify and hold SCS harmless for any damages, including court costs or attorney fees, which might be incurred.

PROHIBITIONS/NO VENDOR CONTRACT FORM

Acceptance of gifts from Bidder/Proposer is prohibited. T.C.A. \$12-4-106. The contract documents for purchase under this RFB/RFP/ITB shall consist of the successful Bidder/Proposers bid and SCSs purchase order. The Bidder/Proposer may request exceptions to terms and conditions and/or request SCS to accept other terms and conditions by means of subsequent documents such as invoices, warranty agreements, license agreements, etc. All subsequent documents shall be open to revision for impermissible language. SCS reserves the right to render the submission unresponsive and subject the submission to rejection if successful terms cannot be negotiated.

PROHIBITION ON HIRING ILLEGAL IMMIGRANTS

Tennessee Public Chapter No. 878 of 2006, T.C.A. \$12-3-309, requires that Contractor attest in writing that Contractor will not knowingly utilize the services of illegal immigrants in the performance of this Contract and will not knowingly utilize the services of any subcontractor, if permitted under this Contract, who will utilize the services of illegal immigrants in the performance of this Contract. The attestation shall be made on the form, Attestation re Personnel Used in Contract Performance ("the Attestation"), which is attached and hereby incorporated by this reference.

SALES AND USE TAX

Before the Purchase Order/Contract resulting from this RFP/ITB is signed, the apparent successful Bidder/Proposer must be registered with the Department of Revenue for the collection of Tennessee sales and use tax as required by T.C.A. §12-3-306.

ASSIGNMENT

Neither the Bidder/Proposer nor SCS may assign this agreement without prior written consent of the other party.

LIABILITIES

The Bidder/Proposer shall indemnify SCS against liability for any suits, actions or claims of any character arising from or relating to the performance under this agreement by the Bidder/Proposer or its subcontractors. SCS has no obligation for the payment of any judgement, or the settlement of any claim made against the Bidder/Proposer or its subcontractors as a result of obligations under this contract.

APPLICABLE LAW

Any contract shall be interpreted under the laws and statutes of the State of Tennessee, T.C.A. §12-3-515. SCS does not enter into contracts which provide for mediation or arbitration. Any action arising from any contract made from this RFP/ITB shall be brought in the state courts in Sumner County, TN or in the United States Federal District Court for the Middle District of Tennessee.

Additionally, it is a violation of state statutes to purchase materials, supplies, services or any other item from a Bidder/Proposer that is a commissioner, official, employee or board member that has any financial or beneficial interest in such transaction, T.C.A. §12-4-101.

FUNDS

The Bidder/Proposer understands and accepts the non-appropriation of funds provision of SCS.

DATA PRIVACY AND SECURITY

Personal Information (PI) includes but is not limited to that information protected by HIPAA, the HITECH Act, FERPA, or Gramm-Leach-Bliley) or such information which would allow a third party to gain access to the personal, medical or financial records of any of any party. Bidder/Proposer represents and warrants that its collection, access, use, storage, disposal and disclosure of PI complies with all applicable federal and state privacy and data protection laws. Bidder/Proposer represents and warrants that Vendor will maintain compliance with the SSAE 16 standard and shall undertake any audits and risk assessments Bidder/Proposer deems necessary to maintain compliance with SSAE16. If PI provided by SCS to Vendor is subject to FERPA. Bidder/Proposer agrees that in its handling of FERPA data it will perform as a school official as that term is defined by FERPA regulations. Bidder/Proposer acknowledges that its improper disclosure or re-disclosure of PI covered by FERPA may, under certain circumstances, result in Bidder/Proposer's exclusion from eligibility to contract with SCS for at least five (5) years. Bidder/Proposer shall provide SCS with the name and contact information for an employee of Vendor who shall serve as SCS's primary security contact and shall be available to assist Customer twenty-four (24) hours per day, seven (7) days per week as a contact in resolving obligations associated with any security incident in which it is reasonably suspected that there has been a breach of information security. Bidder/Proposer shall immediately mitigate or resolve any Security Incident, at Vendor's expense and in accordance with applicable privacy rights, laws, regulations and standards. Vendor shall reimburse SCS for actual costs incurred by SCS in responding to, and mitigating damages caused by, any Security Incident, including all costs of notice and/or remediation incurred under applicable law as a result of the Security Incident.

IRAN DIVESTMENT ACT

By submitting a response, each Bidder/Proposer and each person signing on behalf of any Bidder/Proposer certified, and in the case of a joint submission, each party thereto certifies as to its own organization, under penalty of perjury, that to the best of its knowledge and belief that each Bidder/Proposer is not on the list created pursuant to T.C.A. §12-12-106.

NON-BOYCOTT OF ISRAEL

The Bidder/Proposer certifies that it is not currently engaged in and will not for the duration of the contract engage in, a boycott of Israel as defined by T.C.A. § 12-4-119.

COMPLIANCE WITH CONDUCT STANDARDS

Bidder/Proposer shall be fully responsible for the conduct of its employees, subcontractors, representatives and agents. Loud or offensive music, language or behavior is unacceptable. Tobacco use of any type and vaping is prohibited on SCS property. Contact or interaction with staff or students is not allowed excepted between designated representatives of SCS and Bidder/Proposer.
